EXECUTIVE SUMMARY

This year's report titled "Post Pandemic Purge" is derived from the experiences Kenyans have endured as the country struggled to rebuild itself during the post Covid - 19 period. While the country slowly returns to normalcy through opening up of the economy and loosening of Covid - 19 restrictions, the ugly head of human rights violations, specifically enforced disappearances, has shown itself again. This report highlights cases of human rights violations that were reported, documented and compiled during this post pandemic period in Kenya by HAKI Africa and its partners. The cases range from extra judicial killings, enforced disappearances, torture/assault, sexual and gender-based violence, land/eviction cases and labour related issues among other human rights violations.

In previous years, we witnessed cases where people were abducted and their bodies dumped in places like Tsavo National Park in Taita Taveta County and Tana River. The bodies exhibited evidence of torture with some even tied with ropes and showing signs of burns inflicted on them. This shows that these victims, who have families, loved ones and friends, experienced excruciating pain before their lives were cruelly taken away by their tormentors - some believed to be police officers. Sadly, this trend is continuing as we waddle through the post pandemic period. Further there is a new approach where bodies are tied to stones with ropes, dumped in rivers for them to sink and never be found – case in point is of the 11 bodies found in River Tana, Garissa County in September 2021.

Notably this year there is also increased cases of abductions compared to recent years. These abductions are so blatant in the manner they are carried out. Some of the victims are taken outside courts of law, with most never to be seen again and a few reappearing after months. Others are taken from places of worship, shopping centers and even while driving along the streets of major cities like Mombasa and Nairobi. This happens in the glare of street cameras. In other cases, passers by record the abduction incidences on their phones and share widely on social media. Despite all this evidence, Kenyans are still disappearing without a trace and the State seems unfazed by the trend.

Conversely, the dire economic situation in Kenya, due to effects of the Covid - 19 pandemic, has led to many cases of unemployment and inflation forcing Kenyans into survival mode. This has led to labor

exploitation both locally and in the Gulf countries. Kenyans are exploited by rogue employers who do not provide their workers with employment contracts thus making it difficult to seek any form of redress in the event they get injured or are unlawfully terminated. In addition to this, the lack of contracts has allowed rogue employers to pay workers below minimum wage and in some cases even stop payment altogether.

This report therefore not only highlights the reported cases but also gives key findings and recommendations to both state and non-state actors on what needs to be done to ensure that such cases happen less frequently and Kenyans get to live in a more peaceful and cohesive nation.

1.0 Introduction to HAKI Africa

1.1 Background

HAKI Africa is a human rights organization based in Mombasa working to improve livelihoods and enhance the progressive realization of human rights in Kenya and beyond. Initiated in 2012, the organization promotes partnership between State and Non-State Actors in order to constantly improve the well-being of individuals and communities and ensure respect for human rights and rule of law by all. Particularly, the organization seeks to agitate for the recognition and empowerment of local communities in Kenya to fully participate in rights and development initiatives with a view to improving the standards of living amongst all including the poor and marginalized.

1.2 Vision, Mission, Goal and Motto of HAKI Africa

Vision – A society that respects fundamental rights and freedoms for sustainable development

Mission – To foster the progressive realization of human rights

Goal – To have individuals and institutions who are enlightened about their rights and working together to enhance the development of their communities

Motto – Enhancing the progressive realisation of human rights in Kenya and beyond...

1.3 Strategic Objectives of HAKI Africa

The following are the strategic objectives of HAKI Africa:

Humanity: To empower all people, in particular the poor, weak, marginalized and vulnerable, to understand and promote their human rights in order to preserve the dignity of individuals and communities;

Activism: To mobilize all persons, including women, to be proactive in protecting and defending their rights and ensure fairness and equity across all levels;

Knowledge: To promote knowledge and awareness of social, economic and political issues that will enhance the livelihoods of all people; and

Integrity: To enhance good governance, devoid of corruption and impunity, across all levels for sustainable and progressive realization of the right to development.

2.0 Background of the Report

2.1 Introduction

HAKI Africa in partnership with Pwani Social Justice Centers Working Group (PSJCWG) and its paralegals has compiled this State of Human Rights Report for the year 2021 titled "Post Pandemic Purge". The report's title uses the word Purge to depict the violent removal of people from our society through extra judicial executions and disappearances that have rocked the country throughout the reporting period. This report seeks to highlight the severity of the human rights situation in Kenya with the goal of influencing stakeholders to come up and demand for better application of the Bill of Rights especially for the poor and marginalized.

2.2 Objectives of the Report

The following are the objectives of this report:

- To expose the most glaring human rights violations in 2021;
- To present facts and figures of human rights violations within the Coast region during the year 2021 and offer comparison with the previous years;
- To sensitize and create awareness on human rights violations and recommend ways of overcoming the violations moving forward; and
- To offer a reference document of the human rights situation during the year 2021.

2.3 Methodology

The information in this report was compiled by HAKI Africa in partnership with Pwani Social Justice Centers Working Group (PSJCWG) and paralegals in various counties. Primarily, the compilation was through both virtual and face to face interviews with family members, friends and relatives of victims of human rights violations, witnesses to the violations, government officials and senior police officers.

As an institution rooted at the Coast, most of the cases were brought to our attention by either individuals who physically came to our offices or through PSJCWG and paralegal based in various counties. The report also made use of secondary data which was derived from media and civil society organizations' report during the reporting period.

2.4 Human Rights Situation in Kenya at a Glance Contextual Analysis

During the reporting period, killings and enforced disappearances increased exponentially compared to the previous years. Below, we highlight, contextualize and put into perspective the human rights situation in Kenya to expose the most glaring human rights violations to date.

a) Stifled Economy

As the country slowly recovers from the negative effects of the pandemic, the coastal economy still has to grapple with a stifled economy due to the various government policies that include forcing importers to use the Standard Gauge Railway to transport their containers inland instead of them choosing between SGR and trucking companies. This has negatively affected the Mombasa economy as well as those of towns along the Mombasa-Nairobi Highway like Maungu, Voi and Mtito Andei.

b) Increased Insecurity Due to Lifting of Curfew Restrictions

Our reports suggest that lifting of the lockdown restrictions, though beneficial to the economy, has rendered many vulnerable to human rights violation especially killings, abductions and violent attacks that mostly occur at night or in the wee hours of the morning. Criminal gangs that were otherwise unable to operate during curfew hours have taken advantage of the lifting of curfew restrictions to continue with their violent and criminal ways. Majority of the cases at the coast were witnessed in Old town, Kisauni, Likoni, Mtwapa, Changamwe, Voi, Diani, and Malindi.

c) Rising Cases of Mental Illnesses Dueto Reduced Economic Activities

As explained above, there are many factors that have led to reduced economic activities at the Kenyan Coast and the country at large. These have resulted into reduced household earnings or even complete loss of livelihoods due to massive job losses. The resultant effect is that mental illness cases have increased due to rising cases of depression and trauma. We have recorded cases of people committing suicide including police officers because of depression resulting from living hand to mouth with mounting debt.

d) Rising Cases of Abductions Contributing to Radicalization

This year has seen the highest number of abductions ever recorded. A majority of the victims, who are mainly from the Coast, are yet to be returned to their families. This trend has made many Kenyans resentful of the government. This has pushed some of the young people to take up stances against the government as a means of fighting back because they see the rule of law is being applied selectively between the haves and have not's.

e) Increased Risk of Covid-19 Infections in Informal Settlements Due to Political Campaigns

After the Kenyan President announced an extension of the nationwide Covid-19 curfew and banned political rallies due to high numbers of infections, politicians still continued to hold rallies without observing MoH guidelines thereby risking the lives of poor and innocent Kenyans who are still grappling with a weakened economy. Many Kenyans were infected with Covid-19 and a majority did not have access to health facilities.

3.0 Key Findings on the State of Human Rights at the Coast of Kenya 2021

3.1 Summary of Key Findings


During the reporting period, HAKI Africa in partnership with Pwani Social Justice Centers Working Group and its paralegals received and documented 1,006 cases compared to last year where 1,890 cases of human rights violations were documented. This is a reduction of cases by 63%.

Below is a summary of the specific key findings:

• **Police Related Killings:** It should be noted that during the year 2021 the number of police related killings was 36 which is 12.5% higher than the number of killings in the year 2020 which was 32

- **Killings by Criminal/Terror Gangs**: There were at least 5 cases of killings by criminal/terror gangs documented by the rapid response teams within HAKI Africa and its partners in 2021. This number is lower than in 2020 where 11 such cases were recorded. This is a 27% decrease between 2020 and 2021.
- **Killings by Mobs/Civilians**: HAKI Africa and its partners received and documented 5 cases of persons killed by mobs/civilians in 2021. This was 33% more compared to 2020 which recorded 12 cases of killings by mobs/civilians.
- **Enforced Disappearances**: At least 82 persons were forcefully disappeared in the year 2021. Compared to 2020 where 18 cases were reported, there was an increment of 355%.
- **Torture/Assault Cases**: The loosening of Covid -19 restrictions has led to a reduction in torture and assault cases. In 2021, HAKI Africa and its partners recorded 93 cases which is a 12% decrease compared to the 106 cases in 2020.
- Land/Eviction Related Cases: Land cases were also recorded at 90 cases in 2021 compared to 2020 where we recorded 163 cases. This is a decrease of 45%.
- Labour Related Cases: 327 labour cases were received in 2021 compared to 2020 where 693 labour cases were recorded. This is a decrease of 53%.
- **Sexual Gender Based Violence (SGBV)**: This remained a real concern, there were 341 GBV cases recorded in 2021 compared to 771 cases in 2020 including rape, defilement, sodomy, sexual harassment, physical assault, domestic violence and incest. This is a decrease of 56%.
- Other Cases of Human Rights Violations: Together with the Pwani Social Justice Centers Working Group paralegals, HAKI Africa documented 71 other human rights violations. The cases ranged from accident cases to social media related complaints from members of the public. This is compared to 2020 where 84 cases of other human right violations were recorded. This is a reduction of 15.5%.

Below is a graphical representation of the different human rights violations documented in the year 2020




Graph 3: No of cases documented in 2021 vs 2020

3.2 Detailed Findings

The following is a detailed report of the findings with regards to the state of human rights violations in the Coast region in the year 2021:

3.2.1 Extra Judicial Killings Cases (Police Related Killings)

The prevalence rate of extra judicial killings in Kenya in the year 2021 was higher compared to the previous year. In 2021, there were 36 cases reported against 32 cases in the year 2020. The increase is attributed to the violent manner which the police in Kenya are accustomed to when dealing with situations despite police reforms that have been implemented in the recent past. It is notable that police officers are operating on the motto – shoot first and ask questions later- most of their victims being from poor communities. Criminalization of poverty in Kenya has led to the killing of citizens who are deemed poor and therefore useless and of no consequence.

Below is a table listing the 36 cases of police related killings that were documented in 2021. The table gives the name of the deceased person, his/her age, date of the incident and the circumstance surrounding the killing.

7. Duncan Mutuku	38 years	12/03/2021 CBD Mombasa County	The deceased was allegedly shot by people believed tobe police officers. He succumbed due to severe blood loss.

15. James Mwangi	43 years	26/04/2021 Changamwe Mombasa County	The deceased was allegedly killed together with two others by people believed to be police officers. The incident took place 100 meters from Changamwe Police Station.
16. Abel Alex Kingala	45 years	26/04/2021 Changamwe Mombasa County	The deceased was allegedly was killed with two others by people believed to be police officers.
17. Linus Eldars	31 years	26/04/2021 Changamwe Mombasa County	The deceased and two others were gunned down by people believed to be police officers
18. Collins (second name unknown)	Unknown	29/4/2021 Mathare Nairobi County	A street dweller was allegedly arrested by a police officer and bundled in a Toyota Probox KCW 491N. His body was found in City Mortuary the next day.
19. Juma Changawa	25 years	10/5/2021 Mtomondoni Kilifi County	The deceased family alleged that six (6) police officers who were on patrol on civilian using three Motorbikes without number plates shot Mr Changawa dead at a place adjacent to Corner Bar at Mtomondoni in Mtwapa area. The deceased body was then taken to Coast General Hospital Mortuary for a postmortem. The matter is under investigation by the Independent Policing Oversight Authority.
20. Mohammad Bashir Mahmoud	36 years	13/05/2021 Lavington Nairobi County	The deceased went missing after visiting an Entertainment Lounge. His car was traced to a thicket in Kibiku Area of Ng'ong; it had been burnt to a shell. His body was discovered on the bank of a river in Kirinyaga county. The body had evidence of torture

21.Maurice Ochieng Oulu		25/05/2020 Kisumu West Kisumu County	The deceased collapsed and died on Monday 25/05/2020 at around 10am. He had been arrested and was allegedly severely assaulted by cops attached to Holo Police Post the previous Wednesday at Holo Market in Kisumu West Sub county. He was then taken to Maseno Police Station and detained for the night. He went to the local dispensary after release the following day because he thought it was just normal pain. He succumbed writhing in pain allegedly from the beatings
22. Unknown	Unknown	29/5/2021 Shelly beach Mombasa County	Two suspected thieves armed with pangas were shot dead by a CID officer in Shelly beach area while attempting to steal goods from his shop. CCTV footages circulated widely in social media captured the police officer charging at the suspects while shooting. According to a police report, 20 rounds of ammunition were used against the suspects
23. Francis K. Ngige	50 years	02/06/2021 Changamwe Mombasa County	The deceased was allegedly shot by police officers in Changamwe area
24. Isaac Ochieng'	46 years	02/06/2021 Likoni Mombasa County	The deceased was allegedly shot by police officers in Likoni area
25. Benson J. Ouma	49 years	19/06/2021 Sondu Market Kisumu County	Police Officers based at Pap Onditi arrested Benson Jacob Ouma (49yrs) on allegations of flouting Covid19 rules. It alleged that he was brutalised before being taken for detention at Pap Onditi Police Station. The following day, his wife was called and asked to come for her husband to take him to hospital. On arrival, the wife found Benson unable to stand up or even move. She took him to Sigowet Hospital and was referred to Kericho District Hospital. Checkups revealed that he had broken his spinal cord and was admitted. Benson could not move, support himself or even eat well and was only

			being fed liquid food using a straw. He was referred to Eldoret for corrective surgery and before the family could raise the medical fee, he sadly succumbed to his injuries on 09/10/2021.
26. Unknown	Unknown	20/6/2021 Likoni Mombasa County	The deceased was one of two shot dead by Likoni police station officers at Masjid Bilal, Mzungu Mchafu area in Likoni. The police claimed the two were armed with machetes.
27. Unknown	Unknown	20/6/2021 Likoni Mombasa County	The deceased was one of two shot dead by Likoni police station officers at Masjid Bilal, Mzungu Mchafu are in Likoni. The police claimed the two were armed with machetes.
28. Salim Mwakarima	39 years	26/6/2021 Denyeye Kwale County	The deceased body was found by police officers in Denyenye area. The body exhibited gunshot wounds and torture marks. The family claimed that the deceased had been arrested on the 18/6/2021 at his home by men believed to be police officers.
29. Yusuf Hassan	40 years	29/6/2021 Madhubaha Mombasa County	The deceased body was found at the banks of the Indian Ocean in Madhubaha area having died of drowning. It is alleged that the deceased was escaping police arrest by tossing himself into the water. 32. John Kutemi	41 years	18/8/2021 Changamwe Mombasa County	The deceased was shot multiple times by people believed to be police officers


33. Catherine Njoki	27yrs	24/8/2021 Kiamaiko, roundabout c village Nairobi County	Catherine Njoki was arrested by police officers from DCI Pangani in Kiamaiko area. She was later found dead together with another unknown male victim in city mortuary the next morning.
34. Ayale Asanaq	22yrs	09/09/2021 Kiamaiko Nairobi County	Ayale Asanaq a 22yrs old boy was shot by police officer from DCI Pangani. The police shot on the air to disperse the residents who were requesting to know why the 4 officers were patrolling in Kiamaiko out of their area of jurisdiction and harassing the community. The officers ran from the scene using a personal car they had parked a distance away. Ayale was taken to Jumuiya hospital and pronounced dead on arrival. The case was reported at Huruma police station.
35. Walter Odhiambo	unknown	23/11/2021 Kondele Kisumu County	An eye witness alleged that the deceased had some conflict with cops while they were reveling inside Ringroad bar. The police called for backup who responded and executed him in cold blood even though he had surrendered.
36. Eric Atito	32 years	7/10/2021 Holo Police Post Kisumu County	Eric Atito is alleged to have died while in police cells. It is believed that Eric was arrested by police officers.

3.2.2 Killings by Criminal/Terror Gangs

There were at least 5 cases of killings by criminal/terror gangs documented by the rapid response team within HAKI Africa and its partners and from other secondary sources. This is lower than the 11 cases recorded the previous year.



3.2.4 Enforced Disappearances Cases


The international convention for the protection of all persons describes enforced disappearance as the arrest and detention, abduction or any other form of deprivation of liberty by agents of the state or a group of persons acting with the authorization, support or acquiescence of the state.

In the Coast region, issues of enforced disappearances are particularly at the heart of the very many cases of historical injustices. occasions. several victims' families claim that masked armed men, who claimed be police to officers. took their leaving no trace of them in police cells, hospitals or even morgues.

The stories are disheartening with bodies of unknown persons being collected in national parks while others remain unknown in morgues. As much as the police deny involvement in the alleged cases, it remains their primary role to investigate such cases and also protect its citizens from being abducted. At least 82 Persons were forcefully disappeared in the year 2021. Compared to 2020 where 18 cases were reported. This makes it the year with the highest number of disappearance cases ever recorded in Kenya.

This year HAKI Africa and its partner justice centres documented 82 disappearance cases out of which 46 are still missing while 36 were found/ returned; some have been found alive and others dead. It is noteworthy that most of the abductees found alive claim that their assailants are state agents. When released, the abductees are warned not to disclose any information to human rights organizations, failure to which they risk being abducted again, never to return.

Those willing to risk life and limb to speak to us tell of harrowing stories of being locked in dark rooms for months on end, threatened with death and asked on whereabouts of family members and friends. Some return with physical and psychological scars that HAKI Africa helps redress through counselling and hospital visits.



3.2.6 Torture/Assault Cases

Police officers have failed to uphold the rule of law since they do not understand that they are only custodians of the criminal justice system and that their main role is to enforce the law and not judge and punish those they deem guilty.



Land officers seem to be working with rogue elements to rob innocent Kenyans of their land. This is in addition to the fact that land records are not well protected and can easily be altered to the disadvantage of poor and unassuming land owner.


3.2.8 Gender Based Violence Cases

Gender based violence cases stem from broken marriage relationships where the husband refuses to share wealth acquired during the marriage with wife. the Government offices charged with dealing with such cases are rendered toothless making it difficult for victims to access justice.



HAKI Africa in partnership with PSJCWG and paralegals received numerous other cases which cannot be categorized into either land, labour, torture, gender and extra judicial killings that were reported. These cases mainly center on various government agencies that have in

4.0 Violation of Human Rights Contrary to the Bill of Right

The loosening of restrictions by the Government that infringed on peoples freedom of movement and association has also had some negative effects in terms of the increase in the number of human rights violations. Despite the fact that police brutality and harassment was at its peak during the lockdown period, opening up of the economy has allowed so rogue elements in society to operate freely and infringe on the rights of other citizens. Below are some of the most glaring human rights violations recorded in 2021.

4.1 Violation of Right to Life Contrary to Article 26 of the Constitution of Kenya

From this report, we have noted at least 49 people losing their lives in police related killings, 8 killed my criminal/terror gangs and 16 killed by mobs/civilians. According to the 2010 Constitution, all these people had a right to live. They had a right to security of their person from any harm including death. They should have been put under custody and made to pay for their wrongs (if any). However they were killed instead. This is gross violation of a fundamental human right – the right to life without which all other rights cannot be realized.

4.2 Violation of Freedom from Torture Contrary to Article 15 of the Constitution of Kenya

Torture, especially by National Police Service Officers remained rampant during this post pandemic period. Police officers seem to look for opportunities to torture innocent Kenyans in the course of discharging their duties. While we have recorded torture cases by other individuals that are not members of the NPS, a majority of those recorded have Police Officers as the main culprits. A majority of the enforced disappearance cases recorded seems to have been conducted by state agents where the victims are tortured and even killed. Despite HAKI Africa highlighting these cases, the government has remained mum and chosen not to comment or even act on the ever increasing cases of abduction, torture and murder. Also, the fact that police officers have a duty to protect and defend citizens instead of preying on them warrants reporting.

4.3 Violation of the right to fair labour practices Contrary to Article 41 of the Constitution of Kenya

The Government has a duty and responsibility to protect workers from unfair labour practices by rogue employers. HAKI Africa has recorded 42 cases of labour malpractice that mainly stem from unfair remuneration, unlawful termination, wage theft and refusal to compensate those that have been injured in the line of duty. This is happening despite the fact that HAKI Africa has forwarded the cases to the labour office restitution. The government has also failed to protect Kenyans that have gone to work in the gulf countries despite the fact that HAKI Africa has continuously forwarded such cases for action. Many Kenyans still remain in Gulf countries, unable to access quality healthcare while working in deplorable conditions.



5.0 Key Recommendations

Effective elimination of all forms of human rights violations requires a multifaceted and integrated approach that addresses the need for respect for fundamental freedoms, civil and political liberties as well as economic, social and cultural guarantees. In consideration of the place and situation of human rights violations in coast region and having worked and interacted with the communities, HAKI Africa and partner community human rights centres make the following recommendations to improve human rights adherence:

5.1 National Government

HAKI Africa makes the following recommendations to the national government:

- a) Respect Human Rights During the Post Covid-19 Period As Kenyans struggle to rebuild their lives in the post pandemic period, the Government should ensure that their rights are safeguarded and protected;
- **Deal Firmly with Government Officers who Violate Human Rights**—On various occasions, government officers, including those from security sector have been reported to violate human rights. The National government must lead by example to firmly discipline any such officers so that others can learn from government;
- c) Deal with the issue of enforced disappearances Government should take up the issue and deal with those officers that abduct, torture and kill Kenyans despite the fact that there is a criminal justice system designed to deal with law breakers;

- d) Improve Security National government should immediately take measures to improve the security in the county by allocating more resources to improve security in counties;
- e) Ensure the Right to Protest is Guaranteed The national government should ensure the freedom to assemble, demonstrate and present petitions to government as guaranteed in article 37 of the Kenyan Constitution is not only respected but promoted by government officials;
- f) Make Employment Opportunities Available to the Coastal People National government should bring back Port operations back to Mombasa in order to continue creating more jobs at the Coast, this will reduce the number of people going to Gulf counties in search of employment opportunities;
- g) Address Domestic and Gender Based Violence—The police should do more to protect women and children from domestic and gender based violence. Stern action should be taken against any person who physically, psychologically or sexually assaults any woman or child in the country; and
- h) Police Refresher Training Government should continuously undertake refresher trainings for the police on human rights based approaches and other related issues. This will ensure that police serve Kenyans with courtesy and respect because they are the ones that pay their salaries.

5.2 County Governments

HAKI Africa makes the following recommendations to the county governments:

a) Improve Access to Health – Ensure proper service delivery in emergency situations to care for victims of human rights violations as well as those that contract Covid -19 and other infections. Referral Hospitals must be adequately staffed and equipped to ensure Kenyans access quality healthcare.



- b) Help Curb Land Grabbing—The county governments should work towards ensuring the process of making land search is easily accessible in order to help citizens confirm true ownership and avoid unnecessary disputes in land transactions;
- c) Evictions be done in accordance with the law- The government should ensure that police officers effect eviction orders lawfully by giving Kenyans adequate notice to move instead of destroying the property of those affected. They should also refrain from assaulting citizens during evictions.
- d) Support Human Rights Awareness The county governments should partner with civil society in organizing activities to create awareness of different rights as enshrined in the Constitution;
- e) Implementation of County Action Plan (CAP)—The county governments should spearhead in the implementation of county action plans and ensure that there is a meaningful use of them by all actors; and
- **f) Establishment of SGBV Rescue Centers** The county governments should establish, staff and equip rescue centers for all victims of GBV.

5.3 Communities

HAKI Africa makes the following recommendations to communities:

a) Partnership - Community members should partner with civil society to advocate against injustices and guarantee social equality. This implies coming out to support during demonstrations and other activities.

b) Information Sharing – Members of the public should report all suspicious people or insecurity incidences within their neighborhoods to the relevant authorities in order to curb insecurity.

- c) Abide by the Law-Communities should avoid taking the law into their own hands as seen in occasions where the public conduct mob injustices by killing suspects;
- **Support Peace and Cohesion** Locals, particularly those at the grassroots, should be peace ambassadors by advocating for peace and security within the communities. At all levels they should encourage inter-ethnic cohesion;
- e) Volunteerism Local leaders should work with communities and support the spirit of volunteerism especially among the youth; and
- f) Avoid Hearsay and Abusing Leaders Community members should avoid spreading rumors and ensure they verify any information before sharing it. They should also avoid bad mouthing and abusing their leaders. Instead, they should offer constructive criticism that will help with ideas to improve status quo. They should also avoid getting into violent altercations with fellow citizens who support different politicians.

5.4 Civil Society Organizations

HAKI Africa makes the following recommendations to civil society groups:

a) Roll Out Civic Education – Civil society groups should roll out civic education programs to raise awareness on human rights violations and as the country heads toward the general elections, to empower people politically.

- b) State Officers' Training and Capacity Building Efforts should be made by civil society organisations to train and build the capacity of various national and county government officers in the Coast region.
- c) Hold National and County Governments Accountable Civil society organizations should play their rightful role of being a public watchdog and continue to hold national and county governments accountable. However, this should be done constructively with the intention of improving government services and not merely to disrepute public office holders;
- **d) Support Dialogue and Cohesion** Civil society organisations should act as mediators and enhance dialogue and understanding within communities. They should build bridges between state and non-state actors and ensure cohesion amongst different people;
- e) Support PCVE Efforts Support the efforts of preventing/countering violent extremism (PCVE) through organizing forums and training young people against extremism; and
- **Decriminalization** Those involved in crime can be helped to come out of crime and supported to engage in legal means of earning a living in order to become productive members of the society.
- **g)** Unite-Civil Society Organizations should unite to advocate action for pressing Human Rights Issues like enforced disappearance.

6.0 Conclusion

2021 goes down as the year with the highest recorded number of enforced disappearance cases, it also ranks poorly with the highest number of labour related cases. The pandemic has left workers at the mercy of rogue employers that have decided to exploit desperate Kenyans struggling to earn a living for their families. The government's refusal to heed to the call of Human Rights Organizations to intervene in some of these issues has left Kenyans depressed which has contributed to the increased number of suicide case in the country. It is our hope that the release of this report will provide the Government with a roadmap that will guide its policies as we inch closer to the general elections.
